CONSENT FORM FOR SHARING YOUR INFORMATION

Please read the below. There are **THREE** sections that need a response and where you MUST tick only if you understand and have read the information clearly. You can change your mind later for any reason. [So please do not think you are signing to something definite forever.]

1. SYSTEM ONE - IT GP TO GP CONSENT TO SHARE INFORMATION – sharing your medical information with other GP practices in the UK

If you are ever seen in another Surgery anywhere in the UK, or an Urgent Care Centre or Hospital that uses the same clinical IT system that we do, your records will be seen by the clinical staff involved in your care at that moment in time (nurses and doctors only). ALL your medical data including NHS number, name, address, medication, allergies, vaccines, entire GP record can be accessed.

Likewise if you have been somewhere in an emergency and have been seen by another doctor apart from us, we will be able to see all the details of that consultation. This is a good way to ensure that there is no delay in the clinicians in getting access to your clinical information in case of emergency and it will make your consultation easier. This will also ensure there are no unnecessary repeat tests carried out or wasted time in your treatment waiting for notes to be faxed over. This information will remain confidential and will never be seen for research purposes or any other third party.

If however you are not comfortable with having this data shared, then you need to let us know so that we can record this on the system for you. This will ensure that no data is shared in either direction. Please remember this information is ONLY shared with other clinicians when you are sitting in front of them in a consultation and will not be seen for any other reasons.

2. SUMMARY CARE RECORDS (SCR)

SCR is an electronic record that allows **only THREE BASIC** pieces of information to be shared from your records. This is only to make it easy for you, for example if you go to a Doctor, Hospital or any Care Centre somewhere in another part of the country USING ANY CLINICAL SYSTEM and they need to check if you are allergic to a medication, they will not prescribe this for you. And if you want some medication they will be able to issue this for you.

The only three things which are being uploaded are ALLERGIES, ADVERSE REACTIONS AND MEDICATION.

The sharing of this basic information will make it easier for you to get prompt and accurate care if you go to a GP practice, Urgent Care Centre or Hospital anywhere in England and using ANY clinical IT system (not just our system which is SYSTM1)

CARE.DATA

This is data that is used to produce statistics to monitor and improve national care being delivered to the NHS patients in general. This data includes details of health conditions such as diabetes, heart disease, cancer, high blood pressure etc. only in the form of codes. The data collected WILL NOT include codes that relate to any sensitive information such as sexually transmitted diseases, nor will it include any notes written by the GP.
